Consider adoption of Resolution No. 2016-04 supporting the Federal Aviation Administration's Initiative to address aircraft noise concerns in San Mateo County


### **BACKGROUND**

**RESOLUTION NO. 2016-04**

**A RESOLUTION OF THE CITY OF BRISBANE  
SUPPORTING THE FEDERAL AVIATION ADMINISTRATIONS INITIATIVE TO ADDRESS  
AIRCRAFT NOISE CONCERNS IN SAN MATEO COUNTY**

**WHEREAS**, the communities around San Francisco International Airport have continually voiced concern regarding the increase in aircraft noise from departures from San Francisco International Airport; and

**WHEREAS**, the communities have supported efforts to work with the FAA, the Airport, and the airlines industry to reduce aircraft noise onto the surrounding communities; and

**WHEREAS**, the communities, through organizations such as the SFO Community Roundtable, have developed timely recommendations to the FAA, the airports, and the airline industry to implement actions to mitigate noise; and

**WHEREAS**, recently the FAA developed the Initiative to Address Noise Concerns which was released in November 2015; and

**WHEREAS**, as a Stakeholder in the Bay Area, the SFO Community Roundtable has requested a seat at the table to review the FAA procedures implemented in November 2014 as part of the Northern California Metroplex; and

**WHEREAS**, the City of Brisbane, is looking forward to a meaningful and productive collaboration with the FAA, Roundtable, and elected officials to provide real noise abatement mitigation to the Bay Area.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Brisbane requests that the FAA leadership follow up with community meetings to explain in detail the FAA's plan to address the noise problems.

**BE IT FURTHER RESOLVED** that the City Council of the City of Brisbane requests that the FAA listen and study the ideas submitted by the communities during this process and show commitment to developing some real solutions.
