SECTION 1A: Restoring an existing hydrant means preserving the original design but simply touching it up with a good cleaning and fresh coat of paint. The goal is to update and restore the hydrant to the best of your ability keeping as close to the original design as possible. There are many hydrants in town that have already been painted, some more recently than others. Those that were painted within the last couple of years have been placed on the "not available for restoration" list as they are in relatively good condition and we want to honor the work of the artists for a period of time. Please review the Fire Hydrant Master Catalog and identify which hydrant it is that you are interested in restoring from the "available for restoration" list.

SECTION 2B: Submitting a new hydrant design is slightly more complicated since the process involves the North County Fire Authority. The NCFCA maintains the authority to approve or deny a proposed hydrant design and there are several hydrants in town that must remain painted one solid color for identification and coding purposes. Different colored hydrants and crowns signify pressure levels, etc. New design proposals must be submitted for review to the NCFCA no later than May, 1st. Please review the Fire Hydrant Master Catalog and identify which hydrant it is that you are interested in redesigning from the list.
