# **ADOPTION OF AGENDA**

CM O'Connell made a request to close the meeting in memory of President George H.W. Bush and to add a brief report regarding SFO Roundtable under Mayor/Council Matters.

Mayor Conway made a request to also close the meeting in memory of Rose Capangpangan.

CM O'Connell made a motion, seconded by CM Cunningham to adopt the agenda as amended. The motion was carried unanimously by all present.

# **ORAL COMMUNICATIONS NO. 1**

<u>Nancy Lacsamana</u>, member of the SamTrans Citizens Advisory Committee, provided a brief report on SamTrans new initiatives namely the Bus Rapid Transit on El Camino, a new SamTrans mobile phone application, and the Flex Pacifica Route which is a pilot Microtransit program.

<u>Irving Pineda</u>, outreach specialist for HIP Housing, provided Council with their annual calendars and thanked the Council and the City for their continued support of HIP Housing programs.

<u>Tom Heinz</u>, was disappointed that Councilmembers supported Measure JJ, and went against the Planning Commission's recommendation regarding the General Plan Amendment.
