(The purpose of this public hearing is for members of the public to comment on a proposed General Plan Amendment for the Baylands that would allow for a range of 1800 to 2200 residential units, up to 4 million square feet of new commercial development and companion performance standards and policies including, but not limited to, landfill closure, site remediation, water supply, fiscal impacts to the City, habitat and cultural resource preservation and enhancement, sea level rise and sustainability.

Council will not be making a decision on this General Plan Amendment at this meeting. The public hearing will be continued to the City Council's meeting on June 21 at which time the City Council will consider the Baylands Final EIR, the General Plan Amendment, and ballot question.)
