CM Conway directed the City Clerk to include his statement about the City was not historically in the school bus service business to the minutes of the City Council Meeting of April 27, 2017. With this amendment, CM Conway made a motion, seconded by CM O'Connell to approve Consent Items A-D. The motion was carried unanimously by all present.

### **PUBLIC HEARING**

A. Consider introduction of Ordinance 617 to amend Zoning Text to Chapters 17.02, 17.06, 17.08, 17.10, 17.12, 17.16, 17.18, 17.19, and to add new Chapter 17.33 to Title 17, Zoning, of the Brisbane Municipal Code to define and regulate personal cultivation of medical cannabis by qualified patients and caregivers, and medical cannabis caregivers. Add new Chapter 8.12 to Title 8, Health and Safety, to adopt performance standards for personal cultivation of medical cannabis.

# **B.** Receive update on New Law California Prop 64, the California Marijuana Legalization Initiative

Community Development Director Sweicki reported that this item was continued from the City Council Meeting of April 27, 2017. This proposed ordinance is to update various sections and add a new chapter to Title 17, Zoning, of the Brisbane Municipal code and to Title 8, Health and Safety, to regulate personal cultivation of medical cannabis by qualified patients and caregivers, and medical cannabis businesses.

Community Development Director Sweicki is asking the Council for direction regarding the personal cultivation of nonmedicinal cannabis and non-medicinal cannabis businesses as stipulated in the Adult Use of Marijuana Act (AUMA).

After some Councilmember discussion with Community Development Director Swiecki, Police Chief Macias, Sergeant Garcia and other staff, the Council opened the floor for Public Comment.

Michelle and Randy Dizitser advocated for City permits for delivery only models.

Dana Dillworth believed that dispensaries can be a great source of income for the City.

<u>Michelle Dizitser</u> asked the Council to learn more about the Trailer Bill an upcoming policy in the State to help streamline the regulations for nonmedicinal and medicinal cannabis.

CM Conway made a motion, seconded by CM Lentz, to close the hearing. The motion was carried unanimously by all present.

After more Councilmember discussion, the City Council directed staff to amend Draft Ordinance 617 to expand the Planning Commission-recommended cannabis business regulations to include non-medicinal cannabis manufacturing, distribution (includes transporting and warehousing), and testing (research and development). The Council also directed staff to amend the Draft Ordinance to allow both indoor and outdoor personal cultivation of non-medicinal cannabis on residential properties subject to the same performance standards drafted for personal cultivation of medicinal cannabis.

The City Council further directed staff to do bring back additional information regarding the following:

- the proposed State budget trailer bills intended to unify medicinal and non-medicinal cannabis business regulation
- limitations on the location of cannabis businesses
- the type of retail operations that could be licensed (e.g., walk-up storefronts vs. delivery only)
- how the City could potentially obtain local revenue from cannabis businesses

# PRESENTATIONS

# A. Presentation of proposed Recreational Vehicle (RV) Park on City owned properties at Sierra Point

City Manager Holstine introduced Carl Arnold, of Arnold Hotel Group. Mr. Arnold presented his proposal to build a Recreational Vehicle Park at Sierra Point on City of Brisbane owned parking lot. Mr. Arnold is proposing a glamping experience with Airstream Recreational Vehicles for tourists and not for long term stay.

Bonnie Boswell, Joel Diaz, and Barbara Ebel spoke in support of the project.

Tom Heinz, Dana Dillworth, and Simon Clarke, representing 7000 Marina, all spoke in opposition of the project.

Economic Development Director Bull noted that the City did not actively recruit for this project and that the issue of a land swap was never discussed.

After further Councilmember discussion and questions, the Council directed Mr. Arnold to work with the City Manager to talk to the property owners.

CM Conway made a motion, seconded by CM O'Connell to extend the meeting till 11:00 p.m. The motion was carried unanimously by all present.

# **NEW BUSINESS**

# A. Consider Approval of Supplemental Appropriation for Demolition of Teen Center

The Council will consider whether to approve a \$75,000 budget for the demolition of the Teen Center at 22 San Bruno Ave.—a facility that is beyond its useful life. No repurposing of the site has been identified.

<u>Barbara Ebel</u> asked the City to hire a building dismantler to look at recyclable parts and materials of the building.

Dana Dillworth asked if this particular building was considered a historical landmark.

After some Council discussion, the Council directed City Engineer Breault to look into hiring a building dismantler. CM O'Connell made a motion, seconded by CM Davis, to approve the supplemental appropriation for demolition of Teen Center. The motion was carried unanimously by all present.

After some City Council discussion, CM Lentz made a motion, seconded by CM Davis to approve the Skatepark name to The Brisbane Skatepark with a symbol referencing 8 Mile placed somewhere in the skatepark. The motion was carried with a 4 to 1 vote.
