NEW BUSINESS

H. Further Study of a Residential Permit Parking Program

(It is being recommended that Council select parking permit program options or provide direction to Staff)

Deputy Public Works Director Kinser presented to Council with Complete Streets Safety Committee's (CSSC) modified residential parking permit program study and recommendations after the April 2023 Council meeting, to address the parking scarcity issue in Central Brisbane.

After Council questions, a public comment was made by <u>Roland Lebrun</u> on parking permit program implementation and enforcement. <u>Linda Dettmer and Dariusz Wodziak</u> from the Complete Streets Committee thanked the Council for their attention to this matter and for considering their recommendations.

After Council discussion, Mayor O'Connell made a motion, seconded by Councilmember Davis, to direct staff to prepare a draft letter to residents of Tulare St and Thomas Ave. detailing the program parameters and asking whether the household was willing to be part of the pilot program. The motion passed unanimously by all present.

Staff were also directed to revise the Brisbane Municipal Code Section 10.26 which allows for neighbors to initiate a program. As written the code requires 70% of households to agree to participate in a program. Council asked that the code be rewritten to require a simple majority of households on a defined street segment to initiate a program. Staff will bring the code revisions to Council at a subsequent meeting.
