
Mr. Lawrence:

I write to respond to your letter of April 10, 2024. In your letter, you make a series of discriminatory, offensive and scurrilous comments that attack County employees based on your perception of their religion, national origin and ethnicity. You also attached to your April 10th letter a second letter dated April 9th, in which you claim (falsely, in my view) that you submitted a “(FOIA) request the [Law] Library has totally ignored.” Finally, in your April 14th letter, you demand that I replace Ms. Vasantharam as the attorney assigned to work on your FOIA request.
