Brisbane, CA -- The City of Brisbane will hold a General Municipal Election on November 3, 2020. Three seats on the five-member City Council will be up for election. Incumbents Karen S. Cunningham, and Cliff Lentz have qualified for the ballot, as have candidates Coleen Mackin, R. Jason Nunan and Arthur S. Sun. See the City's website for more information: brisbaneca.org/november2020election.

As was done for the March Primary Election, those voting in the November election will receive a ballot along with a postage-paid envelope. Traditional polling places will not be in operation. There will be several Vote Centers available within the County 29 days prior to Election Day, and additional Vote Centers will be available 3 days prior to Election Day (including weekends). San Mateo County residents can register to vote or update registration information up until Election Day at any Vote Center. The Vote Center in Brisbane will be available beginning Saturday, October 31st, and located in the Community Meeting Room at Brisbane City Hall – 50 Park Place, Brisbane.

There is also an outdoor Ballot Drop Box located in front of City Hall's flag pole, whose ballots will head straight to the

**County Elections Division**. It's currently locked and the Elections Division will unlock it during the first week of October. Sample ballots are scheduled to be mailed starting September 24, 2020, and formal ballots will be mailed shortly thereafter. The first Vote Centers will be available starting October 6, 2020. Anyone living within San Mateo County can drop their ballots in this Ballot Drop Box or cast their ballot in-person at the Vote Center in Brisbane.

In an effort to prevent crowding at the Vote Centers, voters are strongly encouraged to mail their ballots early, or drop them in the various 24-hour ballot boxes that will be available throughout the County. Your sample ballot will provide a listing of where those boxes are located.


















Doing laundry is most likely part of your every day routine. But did you know how important taking care of your clothes dryer is to the safety of your home? With a few simple safety tips you can help prevent a clothes dryer fire.

- ))) Have your dryer installed and serviced by a professional.
- ))) Do not use the dryer without a lint filter.
- ))) Make sure you clean the lint filter before or after each load of laundry. Remove lint that has collected around the drum.
- 3)) Rigid or flexible metal venting material should be used to sustain proper air flow and drying time.
- Make sure the air exhaust vent pipe is not restricted and the outdoor vent flap will open when the dryer is operating. Once a year, or more often if you notice that it is taking longer than normal for your clothes to dry, clean lint out of the vent pipe or have a dryer lint removal service do it for you.
- Weep dryers in good working order. Gas dryers should be inspected by a qualified professional to make sure that the gas line and connection are intact and free of leaks.
- Make sure the right plug and outlet are used and that the machine is connected properly.
- >>> Follow the manufacturer's operating instructions and don't overload your dryer.
- Turn the dryer off if you leave home or when you go to bed.

# DON'T FORGET...

Dryers should be properly **grounded**.

Check the **outdoor vent** flap to make sure it is not covered by snow.

Keep the area around your dryer **clear** of things that can burn, like boxes, cleaning supplies and clothing, etc.

Clothes that have come in contact with **flammable** substances, like gasoline, paint thinner, or similar solvents should be laid outside to dry, then can be washed and dried as usual.

# California High-Speed Rail Authority's San Francisco to San Jose Draft EIR/EIS Public Comment Period Ends Sept. 9



The California High-Speed Rail Authority (Authority) released the San Francisco to San José Project Section Draft Environmental Impact Report (EIR)/Environmental Impact Statement (EIS) for the California High-Speed Rail (HSR) Project. The Draft EIR/EIS has been prepared and is being made available pursuant to both the California Environmental Quality Act (CEQA) and the National Environmental Policy Act (NEPA). The Authority is the lead agency for the San Francisco to San Hose Project Section under both CEQA and NEPA.

The Draft EIR/EIS was made available to the public for a minimum 45-day review and comment period in accordance with CEQA and NEPA. The original comment period was from July 10, 2020 to August 24, 2020, but on August 3rd, Authority staff announced it would be extending the public review period for the San Francisco to San Jose Draft EIR/EIS) to Sept. 9, 2020.

The Draft EIR/EIS is available to view, download, and comment on the Authority's website, **hsr.ca.gov**.





# **Invasive Species to Watch: English Ivy**

Despite romantic notions of ivy-covered castles or the perception of ivy as lovely greenery that grows anywhere year-round, there is an **ugly truth about English ivy. English ivy** (Hedera helix) **is a non-native invasive** evergreen climbing vine that covers everything indiscriminately and is a tree-killer. As a ground cover, English ivy chokes out other plants, creating an "ivy desert" where nothing else can grow. It causes considerable damage to surfaces like wood siding, fences, and foundations and can even damage solid, well-built masonry with its invasive roots. There's a reason those ivy-covered castles are in ruins!



Many think that English ivy is good for preventing erosion. The exact opposite is true. Ivy completely depletes the soil of any nutrients, harbors rodents, provides a breeding ground for mosquitoes, and actually exacerbates erosion problems over time. English ivy is an irritant and can be known to poison humans and dogs. This vine, grown both as an indoor and outdoor ornamental, has caused poisoning in cattle, dogs, sheep, and even humans. Symptoms of ingestion are difficulty breathing, convulsions, vomiting, paralysis, and coma.

This horribly invasive plant poses a huge ecological threat to our community. It is killing local heritage trees. The rootlets burrow under the bark, causing fungus and decay while creating opportunities for disease to enter. Ivy also kills trees by growing up the trunks, overtaking the canopy, and preventing a tree from acquiring the sun that it requires.

**English lvy is especially dangerous** once it escapes the garden because it can spread very quickly through adjacent native woodlands, both by its creeping runners and seed dispersal by birds that eat the berries. Even wildlife is adversely affected by the altered ecosystems caused by an ivy infestation!

Let's start by removing ivy from our precious trees and get rid of this harmful invasive! The Open Space and Ecology Committee, together with the Parks and Recreation Commission, San Bruno Mountain Watch, and city Public Works and Recreation staff have hosted about three habitat restoration days per year, except recently due to County Health Orders restricting gatherings. Some recent habitat restoration days have focused on removing ivy in canyons in central Brisbane and cutting it away from trees, such as the restoration event from July 2018 where two dozen volunteers cleared the Upper Sierra Point Canyon in 3 hours' time.





#### 3 Steps to Remove Ivy from Trees:

- 1. Use garden clippers to cut ivy at the bottom around the entire trunk of all infested trees. The goal is to separate all ivy vines from their source of nutrients in the soil so they will die. On vines thicker than 1", carefully saw through the vine and gently ease it away from the bark.
- **2.** Pull all ivy vines out of the ground around the base of the tree, making a 2' "lifesaver ring" around the tree. This will help protect the tree from re-infestation. Keep this ring clear of ivy.
- **3.** Once cut, you can leave the ivy on the tree; pulling it off could harm the tree. Ivy will gradually blend into the tree bark as it dies.





# Sign Up For the Rain Barrel Rebate Program to Help the Environment and Save Money!



The City of Brisbane, as a participating member agency of the Bay Area Water Supply & Conservation Agency (BAWSCA) and in partnership with Flows to Bay, the San Mateo Countywide Water Pollution Prevention Program, is now **offering rebates of up to \$200** for qualifying rain barrels or cisterns. Rain barrels collect rainwater which is stored for later use and can be used to irrigate your garden.

Rain barrels protect our local waterways by reducing the amount of litter, motor oil, and pollutants that enter the storm drains. Rain barrels can moderate flooding during the rainy winter season, decrease land erosion, and also reduce the amount of moisture that reaches your home's foundation.

Support a local business by purchasing a rain barrel from Brisbane Hardware, make your own rain barrel system, or use a 10% Welcome Discount to purchase a rain barrel from BlueBarrel! Check what kind of rain barrel qualifies for the rebate or read about the program requirements at **flowstobay.org** or BAWSCA's webpage, **bayareaconservation.org/rebates/barrels**. Then, sign up using the online application (recommended for the fastest rebate) or download the paper application found on the Flows to Bay site.



# **Know When You Need to Evacuate, and Prepare NOW**

September is National Preparedness Month, and the August CZU Lightening Complex Fires where by August 21st, over 64,000 residents had been evacuated, and where over 50,000 acres had burned with the fires at 0% containment, the need to be prepared can't be more clear. If an incident should occur here in Brisbane, local authorities will use SMCAlert to indicate one of three things:

#### **Shelter in Place**

Go indoors, shut and lock doors and windows and prepare to self-sustain until further notice.

#### **Evacuation Warning**

There is a potential threat to life and/or property, and those who require additional time to evacuate, and those with pets and livestock, should leave now.

#### **Evacuation Order**

There is an immediate threat to life. This is a lawful order to leave now, and the area is lawfully closed to public access.

# **EXPANDED Curbside Pickup Services at the Brisbane Library**

This safe, contactless service is available by appointment at all 12 San Mateo County Libraries (SMCL) locations, **Tuesday – Saturday from 11-4 PM**, except during holiday closures. Here's how Curbside Pickup works!

- 1. Browse <u>smcl.org</u> (or the SMCL mobile app) and place your item(s) on hold.
- 2. After you receive your email confirmation that your item(s) are ready, **schedule** a time for your pickup.
- 3. Arrive during your scheduled appointment, **pick up** your item(s), and enjoy!

If you have any issues with placing items on hold, scheduling Curbside Pickup, or have mobility issues or special considerations, call SMCL's customer service team at **1-833-YES-SMCL** (1-833-937-7625) or text them at **(650) 851-0147**. **Note:** items are held in quarantine for 96 hours.

# Short Term Rental Regulations

On June 18, 2020, the Brisbane City Council adopted urgency Ordinance 656, immediately implementing permitting requirements and operational standards for short term rentals (STRs) in Brisbane. The Ordinance defines STRs as rentals of homes for less than 30 consecutive days; rentals of homes for 30 or more consecutive days are not regulated by the City.

The urgency ordinance is effective immediately. Hosts must obtain a STR permit by September 16, 2020 (90 days from the date of the ordinance's adoption) to host STRs, subject to the rules below.

### What's Allowed?

- Homeowners may host short term rentals (STRs) if the home is their permanent residence (they live there at least 275 days out of the year)
- STRs must be "hosted," where the host is on the property during the rental
- STRs must be in a single-family home
- Up to two rooms in the home may be used for STRs (one parking space required per room on the property)

#### What's Prohibited?

- STRs can't be hosted by long-term renters.
- "Unhosted" or "entire home" rentals, where the host isn't on the property during the rental, are **prohibited**.
- STRs are not allowed in apartment buildings or accessory dwelling units.
- Hosts can't rent more than two rooms.
- Hosting STRs without a STR permit from the City is prohibited.

#### What's the Permit Process?

#### Applying for the Permit

Homeowners who qualify to host rentals can apply for a STR permit on the City's website at: <a href="mailto:brisbaneca.org/STR">brisbaneca.org/STR</a>. The application is web-based and requires an internet connection and web browser to complete. If you need assistance with your permit application, please call the Community Development Department at (415) 508-2120 or email <a href="mailto:planning@brisbaneca.org">planning@brisbaneca.org</a> to arrange for assistance at City Hall (please note: City Hall closure dates and health screening requirements are in place during the COVID-19 pandemic).

Make sure you have these documents in a digital format (image file or PDF) to upload with your application:

- ✓ Proof of homeownership (like a property tax bill, or income tax homeowner exemption document)
- ✓ Three documents proving the home is your permanent residence (like utility bills, bank/credit card statements, driver's license, vehicle registration receipt, etc.)
- ✓ Proof of short term rental insurance with coverage of at least \$500,000
- ✓ Floor plan of the home showing where the rooms to be rented are located in the home (may be hand drawn; does not have to be to scale)
- ✓ Site plan of the property showing the location of the home on the property, and the location and number of parking spaces (may be hand drawn; does not have to be to scale)

A planner will be assigned to your application, who will contact you to confirm the status of your application within 10 days of submittal and walk you through the permit process. If they need more information from you to process the application, they will let you know at that time.

#### Neighbor Noticing and Zoning Administrator Action on Permit

Once the City has all the information required to process your application, the Zoning Administrator will mail a notice of the application to neighbors (including property owners and occupants) of homes in the neighborhood. Neighbors can send written comments on your application to the Zoning Administrator within 21 days of the notice date.

After the 21-day notice period ends, the Zoning Administrator will approve the application if it meets these findings:

- ✓ The application meets all operating standards and requirements of the ordinance;
- ✓ The dwelling unit complies with life safety standards as certified by the applicant and confirmed by an on-site inspection by Building Department and/or North County Fire Authority staff; and
- ✓ The dwelling unit is not the subject of an active code enforcement action or administrative citation from the City in the past year.

### Permit Approved? Great! Now What?

If your permit is approved, you can begin hosting short term rentals! Keep the following rules in mind when creating your STR listing and while hosting:

- + Obtain a business license from the Finance Department and pay Transient Occupancy Tax (TOT) annually. More information can be found here: brisbane.bizlicenseonline.com.
- + Include your approved permit number in all listings for your rental on any listing website.
- + Provide the STR "Good Neighbor" policies to your guests. Be a good neighbor by abiding by check-in and check-out times (between 7 AM and 10 PM) and making sure STR renters do not host events or parties and abide by quiet hour policies (between 10 PM and 7 AM).
- + If you're renting two rooms, both rooms must be rented to the same party; do not book individual rooms to different rental parties.
- + Make sure the STR occupancy doesn't exceed two people per room (kids excluded) in the evening (after 10 PM), and four people per room (kids excluded) in the daytime (after 7 AM).

The City wants property owners to be able to enjoy the economic use of their property and welcomes visitors to Brisbane, while also making sure our residential neighborhoods remain safe and enjoyable for long-term residents. Remember that permits can be suspended or revoked in event of violations of the City's STR regulations. Thank you for reading through the City's new Short Term Rental Regulations for residential rentals.
