

Watch Out for Mosquitoes in Warm Weather



Protecting public health since 1916



Did you know that mosquitoes can complete their entire life cycle in as few as 7 days? Warm weather and lack of rain mean stagnant water in storm drains and backyards can quickly breed mosquitoes. San Mateo County Mosquito and Vector Control District would like to remind you to dump or drain any standing water at least once a week.

If you notice mosquitoes around your house, call the District or submit an online service request at smcmvcd.org/request-service for a technician to investigate the problem and control the mosquitoes.

Water Heating Gets Electrified at Station 81

As part of the City's ongoing efforts to reduce fossil fuel use and emissions in our facilities, the two natural gas water heaters at the Fire Station were replaced with heat pump water heaters in December. After a couple months of use, fire crews reported they are working great with plenty of hot water.

The City was able to take advantage of a pilot program offered through San Mateo County Energy Watch and PG&E's Government and K12 program, which made the upgrade at no cost to the City. The program's implementers, Willdan, began with a review of City facilities to determine eligibility and which water heaters would be a good fit for the program. In mid-December, subcontractor Enovative Mechanical and Energy, completed the permitting and installations.

"Brisbane's willingness to participate in Willdan's heat pump water heater pilot program provided the real-world information necessary to scale and replicate this program across PG&E's territory. We sincerely appreciate Brisbane's willingness to lead by example and we are excited to be able to offer the same service to other cities interested in reducing energy use and greenhouse gas emissions," said Lou Jacobson, Willdan Program Manager for the Government and K-12 Program.



Willdan estimated these new units represent a 70% reduction in lifecycle CO2 emissions, with savings equivalent to the annual energy use of seven homes. The City is grateful for the partnership that enabled this progress towards our carbon neutrality goals and looks forward to continuing our journey towards fossil-free resilient buildings!

Want to make the switch? Homeowners can also save money and reduce their carbon footprint by replacing their gas water heater with a heat pump water heater running on clean electricity. News on the 2022-2023 Housing Element Update



Last month, the Planning Commission reviewed results from the Balance Brisbane survey, an interactive tool that the City used to get community feedback on potential locations in the City to zone for new housing units. The Commission also discussed how to meet the City's Regional Housing Needs Allocation (RHNA), a State-mandated number of housing units affordable to households of all income levels that must be accommodated in our zoning regulations. Because the City's current zoning does not accommodate all of the RHNA, the Commission considered the potential to rezone various properties throughout the City to make up the shortfall. The Commission reviewed each property included in the Balance Brisbane tool and considered the constraints and opportunities unique to each. SB 1383 Requires Businesses to Also Get into Compliance



Senate Bill 1383 requires Californians to separate organic waste such as yard trimmings, food scraps, food-soiled paper, clean paper & cardboard from landfill-bound garbage. If you are not already making full use of your green and blue bins, it's time to start!

In last month's STAR, we focused on the need for residents to comply; this month, we're focusing our outreach towards the business community. Businesses that were shown to not be in compliance due to not having a green container to separate organic waste, were sent letters in early February letting them know that the City will begin assessing citations to non-compliant businesses on January 1, 2023.





Midtown Mural Restoration Project

Restoration efforts for the mural on the side of Midtown Market got underway in early February. This is the third project to be funded through the City's Public Art Fund (the first being the racoon being replaced at Costaños Canyon and the second being the glass butterflies at the new Brisbane Library).

The first few restoration steps had to do with stabilization - reinforcing areas of paint under areas of coating loss, re-adhering flaking paint to the substrate, and filling/repairing losses to the substrate to create a smooth surface for the restoration work that will come afterwards. Conservation Assistants Samantha Emmanuel and Brandon Phuong, working with Site & Studio Conservation, are completing this important stabilization work. You can see the difference their work is making, when comparing the first photo against the second; the colors in the first are so much more vibrant!





The mural was commissioned by BES/PTO (formerly BEST/PTO) in 2002 as a fundraiser for the local schools. Its artist, world-renown muralist Mona Caron, will be returning to Brisbane to restore the mural. Afterwards, it will get a new coating applied by Site & Studio Conservation, which includes an anti-graffiti and anti-UV component so it can continue to delight passer-bys for many more decades to come.
