The City of Brisbane wishes to express solidarity with Ukraine in the struggle to defend their nation against the unlawful and violent aggression of the Putin regime.


This unwarranted invasion has displaced over a million Ukrainians, cost hundreds of lives, and injured thousands more.

In March, IT and Communications staff worked with MCTV to bring back the 24/7 cablecast stream to the City's website. City's IDEA Committee Kicks Off!



On March 16th, the City's newest committee, the Inclusion, Diversity, Equity & Accountability (IDEA) had their very first meeting over Zoom. Committee members Alex Horton, Mangesh Kolhatkar, William Lok, and Dianne Oseto were joined by City staff for introductions and for the faces that will be assisting this "think tank" as they create programs, events, and initiatives for the community at-large. Now they know who can assist them with things such as closing roads, large-scale community events, etc. The Committee also got an overview of their role as committee members and a crash course in the Ralph M. Brown Act by the City's legal counsel, Michael Roush. City Clerk Ingrid Padilla (lead) and Communications Manager Caroline Cheung (support) will be staffing the Committee, with Assistant City Manager Stuart Schillinger serving in an advisory role.

Development Applications in Brisbane

The first quarter of 2022 has seen a number of commercial and housing developments move forward. Included is the 600 plus acre Brisbane Baylands. Under the direction of voter-approved Measure JJ, which updated land use



specifications under the General Plan, the project sponsor will be submitting a Specific Plan for 1,800-2,200 housing units and up to 7 million square feet of new commercial development including two hotels. This is a project that will commence environmental review this calendar year, prior to public hearings before the Planning Commission and ultimately, the City Council. A comprehensive Development Agreement that will outline timing, obligations, and community benefits will also be negotiated between the parties.

The redevelopment of the Guadalupe Quarry as an extension of Crocker Park, consistent with the 1994 General Plan, is also proposed. Approximately 1 million square feet of modern warehouse space is anticipated. This project will also be required to donate substantial lands for San Bruno Mountain open space, as well as provide other community benefits. An environmental impact report (EIR) is currently being prepared and is expected to be published in late 2022, followed by public hearings before the Planning Commission and City Council.



At Sierra Point, there are two significant private project

applications, one of which has been submitted and the second of which was presented to the City Council as a courtesy review at their February 17th meeting.

The submitted project from Healthpeak (Sierra Point Towers) at 2000 Sierra Point Parkway proposes two new life science buildings, totaling approximately 850,000 square feet and a new parking garage. This project also requires an EIR and will be subject to public hearings.

The other project that was preliminarily presented to the City Council is a combination life science/hotel project

by Universal Paragon Corporation located on the only remaining vacant, privately-owned parcel at Sierra Point. It will also be subject to the preparation of an EIR and public hearing process.

As noted above, all of these projects will require extensive environmental review. Issues such as water availability, impacts on traffic, need for affordable housing, open space and recreation needs, and other community and regional impacts will be evaluated as these projects work their way through the planning process. DID YOU KNOW...

Each April, your Sewer Charge on your utility bill may change, as it's based on the amount of water used during the winter months (mid-October to mid-February). What is the Community Transportation Benefits Program?

The Community Transportation Benefits Program (Program) is sponsored and funded by the San Mateo County 101 Express Lanes. The Program helps qualifying San Mateo County residents cover some of their transportation costs. Participants can choose from one of two options that meet their needs:

- 1. Clipper Card with a value of \$100 (annual benefit); or
- 2. FasTrak® toll tag/transponder with value of \$100 (one-time benefit)

We will also help you determine if you are eligible for other Clipper Card discount programs and assist you with enrollment.

Am I eligible?

To qualify for benefits under the Program, you must be:

- A resident of San Mateo County, and
- Age 18 or older, and
- Eligible to receive at least one benefit provided through the San Mateo County Core Service Agencies Network, or
- Earning an Individual Income at or below 60% of the county Area Median Income (\$76,740 for 2021).

How do I enroll?

There are eight Core Service Agencies that work in close collaboration with the Human Services Agency of San Mateo County to provide you and your family with basic emergency and support services. You can enroll for the Community Transportation Benefits Program through any of the following Core Service Agencies either virtually or in-person. Their contact information can be found below:

Brisbane Parks and Rec Awarded Funding from San Mateo County's Summer 2022 Enrichment Grant Program



The focus on the County's 2022 Enrichment Grant Program is on developing the academic, social, emotional, and physical needs and interests of youth through hands-on, engaging learning experiences. Brisbane Parks and Rec was informed in March that they are one of the program's grant recipients, in the amount of \$8,300, and intend to fully utilize the funds to support their 2022 Summer Camp. Specifically, the funds will expand trainings for childcare staff to support SED (Social Emotional Disability) students, such as in the area of physical education, the purchase of STEAM project kits and supplies, and other added enrichment opportunities, so campers can develop new interests and build new skills. News on the 2023-2031 Housing Element Update

Last month, the Planning Commission wrapped up its series of workshops on the Housing Element update with a review of the City's goals and policies related to maintaining and preserving existing housing, developing new housing to meet our Regional Housing Needs Allocation (RHNA), and ensuring fair and protected access to housing for all households in Brisbane. Planning staff is now preparing the draft Housing Element and anticipates publishing it for public review and comment in April (minimum 30 days), with a public hearing with the Planning Commission following in May. Annual Building Benchmarking Reporting Period Opens -Compliance Deadline May 15th

The Brisbane Building Efficiency Program (BBEP) recently announced its second year of mandatory reporting. Buildings required to comply should receive notification letters and/or emails instructing them to submit their energy and water benchmarking data by May 15, 2022 through the Energy Star Portfolio Manager reporting link: <u>brisbaneca.org/bbep2021</u>.



The City of Brisbane created the program to help make existing buildings more energy and water efficient, saving owners money, improving the safety and comfort of our building stock, and reducing emissions that drive climate change. Established

by a City ordinance in 2019, the program requires most owners of local buildings 10,000 square feet or more to benchmark their building's energy and water use and report results annually on May 15th, starting last year.

Roughly 87% of buildings on the BBEP roster achieved some level of compliance in 2021, the first reporting year which covered the 2020 calendar year. Building owners and representatives that reported last year should find the process simple to continue. Buildings which did not report last year are encouraged to contact City staff at <u>bbep@brisbaneca.</u> org or (415) 347-2010 to come into compliance.
