## NOTICE OF PUBLIC HEARING

Notice is hereby given that a public hearing will be held by the City of Brisbane Planning Commission on **Thursday, May 27, 2021, at 7:30 p.m., virtually via Zoom, videoconference broadcast on local Comcast channel 27 and the City's YouTube channel**, to consider the following matter:

APPLICATION NO.: **Sign Program Amendment SR-3-21**

APPLICANT/OWNER: **Chris Mateo, applicant; HCP LS Brisbane, LLC, owner**

LOCATION: **2000 Sierra Point Parkway  
(Assessor's Parcel No. 007-164-010)**

ZONING: **SP-CRO Sierra Point Commercial District**

REQUEST: **Amendment to the Sierra Point Sign Program Standards to permit a new 6'-3" tall x 16' long illuminated entry monument sign and three new flagpoles on the southwest corner of 2000 Sierra Point Parkway at the intersection of Sierra Point Parkway and Marina Boulevard.**

ENVIRONMENTAL STATUS: **Categorical Exemption per State CEQA Guidelines Section 15311(a) – this project falls within a class of projects which the State has determined not to have a significant effect on the environment. The exceptions to this categorical exemption referenced in Section 15300.2 of the CEQA Guidelines do not apply.**
