NOTICE OF PUBLIC HEARING

Notice is hereby given that a public hearing will be held by the City of Brisbane Planning Commission on <u>Thursday</u>, <u>October 14, 2021</u>, at 7:30 p.m., <u>virtually via videoconference broadcast on local Comcast channel 27 and the City's YouTube channel</u>, to consider the following matter:

LOCATION: 2000 Sierra Point Parkway; Assessor's Parcel No. 007-164-010

ZONING: SP-CRO Sierra Point Commercial District

REQUEST: Review of proposed grading consisting of 438 cubic yards of soil,

including 427 cubic yards to be exported from the site, to accommodate placement of a previously approved monument sign and landscaping at the northeast corner of the intersection of Sierra

Point Parkway and Marina Boulevard.
