## NOTICE OF PUBLIC HEARING

Notice is hereby given that a public hearing will be held by the City of Brisbane Planning Commission on **Thursday, October 14, 2021, at 7:30 p.m., virtually via videoconference broadcast on local Comcast channel 27 and the City's YouTube channel**, to consider the following matter:

APPLICATION NO.: **Interim Use Permit 2021-UP-2**

APPLICANT/OWNER: **Eric Aronsohn/Tuntex USA Inc. (Baylands Development Inc.)**

LOCATION: **3435 Bayshore Blvd; Assessor's Parcel No. 005-162-240 (southern portion)**

ZONING: **C-1- Commercial Mixed Use (Baylands)**

REQUEST: **An Interim Use Permit is requested for the continued operation of an approximately 4,000 square foot native plants nursery, Mission Blue Nursery, at 3435 Bayshore Boulevard, for 5 years.**

ENVIRONMENTAL STATUS: **Categorical exemption per State CEQA Guidelines Sections 15301-- this proposal falls within a class of projects which the State has determined not to have a significant effect on the environment. The exceptions to this categorical exemption referenced in Section 15300.2 do not apply.**
