### NOTICE OF PUBLIC HEARING

Notice is hereby given that a public hearing will be held by the City of Brisbane Planning Commission on Thursday, October 28, 2021, at 7:30 p.m., virtually via videoconference broadcast on local Comcast channel 27 and the City's YouTube channel, to consider the following matter:

REQUEST: Proposed Interim Use Permit to establish a non-commercial tree

nursery on approximately 3.5 vacant acres for a term not to exceed 5 years. The facility is intended to serve as a source of trees for the

applicant's use.

**ENVIRONMENTAL** 

STATUS: Categorical exemption per State CEQA Guidelines Sections 15304—

Minor public or private alterations in the condition of land, water and vegetation- a class of projects which the State has determined not to have a significant effect on the environment. The exceptions to this categorical exemption referenced in Section 15300.2 do not apply.
