NOTICE OF PUBLIC HEARING

Notice is hereby given that a **hybrid public hearing** will be held by the City of Brisbane Planning Commission on <u>Thursday, May 9, 2024</u>, at 7:30 p.m., allowing public participation in-person at Brisbane City Hall, 50 Park Place, Brisbane, AND virtually via Zoom, broadcast on local Comcast channel 27 and the City's YouTube channel, to consider the following matter:

REQUEST:	Zoning Text and Map Amendments: Brisbane Municipal Code Titles 16 and 17 – text amendments to amend Chapter 17.04 Establishment of Zoning Districts and to add Chapter 17.05 Residential Two Unit Overlay District to provide for urban lot splits and two-unit developments in the R-1 and R-BA single family residential zoning districts and related amendments to the tentative and final parcel map provisions in Chapter 16.12 and the definitions in Chapter 17.02, as provided in California SB 9 (2021), provided in Gov't Code Sections 65852.21 and 66411.7 and amended 66452.6.; along with a zoning map amendment to show the overlay district extent.
ENVIRONMENTAL	
STATUS:	Exempt from the California Environmental Quality Act (CEQA) pursuant to California Government Code Section 15061(b)(1) & (3), Section 15183 relating to the implementation of the Housing Element, and because it involves code amendments pursuant to California Government Code Section 65852.21(j) and Section 66411.7(n) relating to the implementation of SB 9 (2021). The exceptions requiring further review as might be necessary to examine a project specific significant effects does not apply.

HOW TO VIEW THE APPLICATION MATERIALS


