NOTICE OF PUBLIC HEARING

Notice is hereby given that a **hybrid public hearing** will be held by the City of Brisbane Planning Commission on <u>Thursday, May 9, 2024</u>, at 7:30 p.m., allowing public participation in-person at Brisbane City Hall, 50 Park Place, Brisbane, AND virtually via Zoom, broadcast on local Comcast channel 27 and the City's YouTube channel, to consider the following matter:

APPLICATION NO.: Zoning Text Amendment 2024-RZ-2

APPLICANT/OWNER: City of Brisbane

LOCATION: Citywide

ZONING: Multiple zoning districts.

REQUEST: Brisbane Municipal Code Title 17 - Omnibus Zoning Amendments to

modify the development standards for multifamily and residential mixed use zoning districts consistent with California Senate Bill SB 478 ("housing opportunity act"), Government Code Section 65913.11, and as provided in the 2023-2031 Housing Element for building heights, lot coverage and floor area ratios, and related amendments, including amendments to provide administrative restructuring of the development standards for the residential and mixed use zoning districts, provided in Chapters 17.06, 17.08, 17.10, 17.12, 17.14 and 17.16; to amend certain definitions contained in Chapter 17.02; the reviewing authority for design permit modifications in Chapter 17.42 and variances in Chapter 17.46; exceptions to the district development regulations provided in Chapter 17.32 within a new Chapter 17.47; the appeals procedures in Chapter 17.52; and re-title and amend the

zoning administrator procedures in Chapter 17.56.

ENVIRONMENTAL STATUS:

Exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Section 15061(b)(3) and Section 15183 relating to the implementation of the 2023-2031 Housing Element. The exception requiring further review as might be necessary to examine a project specific significant

effects does not apply.

The public may observe the Planning Commission meeting and/or address the Commission remotely <u>or</u> in person. Planning Commissioners shall attend in person unless remote participation is permitted by law. The Commission may take action on any item listed on the agenda.
