## NOTICE OF PUBLIC HEARING

Notice is hereby given that a public hearing will be held by the City of Brisbane Planning Commission on **Thursday, May 28, at 7:30 p.m., virtually via videoconference broadcast on local Comcast channel 27 and the City's YouTube channel**, to consider the following matter:

APPLICATION NO.: **EX-2-20**

APPLICANT/OWNER: **Dawn Jedkins (DES Architects + Engineers, applicant; HCP Life Science Reit Inc, owner.**

LOCATION: **2000 Sierra Point Parkway/8000 Marina Boulevard  
(Assessor's Parcel Nos. 007-164-010 & 007-164-020)**

ZONING: **SP-CRO Sierra Point Commercial District**

REQUEST: **Grading Review for approximately 942 cubic yards of soil cut, with approximately 600 cubic yards being exported and 342 cubic yards being used as fill, to accommodate re-landscaping with stormwater treatment units and accessibility improvements to serve the existing office buildings.**

ENVIRONMENTAL STATUS: **Categorical Exemption per State CEQA Guidelines Section 15304- this project falls within a class of projects which the State has determined not to have a significant effect on the environment. The exceptions to this categorical exemption referenced in Section 15300.2 of the CEQA Guidelines do not apply.**
