NOTICE OF PUBLIC HEARING

Notice is hereby given that a public hearing will be held by the City of Brisbane Planning Commission on <u>Thursday, June 25, 2020</u> at 7:30 p.m., virtually via videoconference broadcast on local Comcast channel 27 and the City's YouTube channel, to consider the following matter:

APPLICATION NO .:	Grading Review EX-4-19
APPLICANT/OWNER:	Abraham Zavala, applicant/ Huang John & Chen Joy Trust, owner.
LOCATION:	338 Kings Road (Assessor's Parcel No. 007-471-170)
ZONING:	R-1 Residential District
REQUEST:	Grading Review for approximately 357 cubic yards of soil cut and export to accommodate a new driveway and additions, including a two-car attached garage, for an existing single-family dwelling. The subject property is a 6,400 square-foot lot with a 43% slope and has no on-site parking or direct street access.
ENVIRONMENTAL STATUS:	Categorical Exemption per State CEQA Guidelines Section 15301(e) and - this project falls within a class of projects which the State has determined not to have a significant effect on the environment. The exceptions to this categorical exemption referenced in Section 15300.2 of the CEQA Guidelines do not apply.
