NOTICE OF PUBLIC HEARING

Notice is hereby given that a public hearing will be held by the City of Brisbane Planning Commission on **Thursday, September 10, 2020, at 7:30 p.m., virtually via videoconference broadcast on local Comcast channel 27 and the City's YouTube channel**, to consider the following matter:

APPLICATION NO.: Use Permit UP-1-20 & Grading Review EX-1-20

APPLICANT/OWNER: Wilson Yu, applicant and owner

LOCATION: 130 Sierra Point Road
(Assessor's Parcel No. 007-193-050)

ZONING: R-1 Residential District

REQUEST: Use Permit modifying the parking regulations of the Brisbane Municipal Code (BMC) to allow two nonconforming covered parking spaces within an existing, detached garage and Grading Review for approximately 150 cubic yards of soil cut and export and removal of seven mature trees to allow construction of a new 3,557 square foot home. The subject property is a 5,000 square foot lot with a 33% slope and no existing on-street parking.

ENVIRONMENTAL STATUS: Categorical Exemption per State CEQA Guidelines Sections 15303(a) and 15301(l) - this project falls within a class of projects which the State has determined not to have a significant effect on the environment. The exceptions to these categorical exemptions referenced in Section 15300.2 of the CEQA Guidelines do not apply.

HOW TO VIEW THE MEETING

This meeting will be conducted exclusively via videoconferencing in compliance with the Governor's Executive Order N-29-20 and the San Mateo County Health Officer's amended Health Order C19-11 effective June 17, 2020. The purpose of this virtual public meeting is to provide the safest environment for staff, Planning Commissioners, and the public while ensuring public participation. The Community Meeting Room at City Hall will remain closed and inaccessible to the public until large public gatherings are permitted to resume.
