The Heart of the Policy Matter

- •Define the Problem What is happening that we want to change?
 - An example would be too many potholes in the street.
- •Determine the Cause of the Problem Why is this occurring
 - Street base isn't thick enough
 - Cracks in street fill with water and freeze
 - Road repairs not properly done
- •Possible Solutions Once some causes are determined can work on what can fix the issue.
- •Does the solution make it better?
 - If so for whom



Items to Discuss in Decision Making

- How you define the problem can change possible causes and solutions
- What information do you need to determine causes?
 - How easy is it to get information?
 - Are there suitable proxies for information not available?
- Who do solutions help and hurt?
- What are the benefits of the solutions?
- What are the downsides to the solutions?



Items to Discuss in Decision Making

- Are the solutions scalable?
 - Too much/too little
- What are the costs of the solutions
- Where have the solutions been tried before
 - What were the results
 - Are the results repeatable



The Team and Process

- What is the Role of the Committee?
 - Advisory to City Council
 - Determine Issues to be explored
 - Determine advisability of potential solutions
 - Represent the Community concerning Issues explored
- What is the Role of Staff?
 - Provide information to the Committee
 - Research issues raised by Committee
 - Provide potential solutions and research benefits and drawbacks of solutions
 - Determine if additional expertise is needed and advise Committee
