Subject: Committee Work Plan Brainstorm

PURPOSE

Continue discussion of policy issues and events committee members would like to include in the IDEA Committee Work Plan

RECOMMENDATION

It is being recommended for the members to brainstorm policy issues and events committee members would like to include in the IDEA Committee Work Plan and for the subcommittees to meet at a future date and provide more detailed action steps.

BACKGROUND

On July 20, 2022 staff provided Committee members a presentation on best practices in events and policy making. Committee members were also assigned to one of two subcommittees— namely: the Events Subcommittee and the Policy Making Subcommittee.

DISCUSSION

Committee Members will draft a work plan listing the Policy Issues and Events the IDEA Committee will take on for the coming year. The Brisbane City Council will be asked to consider approving the Committee's work plan at a future City Council Meeting.

Staff would like to have the Committee Members to consider the following during the brainstorm session:

Events—Consider the areas for public outreach instead of the events the City already does.

- What is IDEA is trying to achieve with the outreach--who do we want to reach out to, and what we hope the outcome of the outreach will be?
- What are the possible ways to make this happen?

Policy—Consider what are different areas the City interacts with when it comes to Policy.

- Are there areas that the City Council should be looking at broadly?
- What is it that the IDEA Committee believes is not working from a policy perspective and then the types of policies that might fix them?

• Does the committee feel decisions are not made with the right representation from the community and do certain segments of the community feel left out decision making or being able to reach out to the City for help?
