## Happy Independence Day!

It's amazing how quick time flies when you're having fun...or when you're busy. Half the year disappeared like a blink of an eye...poof, vanished, gone! No matter how you look at it though, time's not slowing down, and here we are looking at the business end of another birthday for our Country—an amazing 245 years; now that's something to celebrate!

Another call for celebration is a breath of fresh air— California finally being able to re-open after 15 loooong months of dealing with the COVID shut-down. I can honestly say a pandemic was never on my bucket list, nor do I want to experience anything of the sort again. Once was enough for me, and I'm sure many of you, if not all, feel the same. California Department of Public Health and the CDC still have certain restrictions in place, so please take a moment to know what they are. In addition, and in compliance with the CDC, if you're fully vaccinated, masks are optional within the Marina office. Any patrons who are not fully vaccinated are still required to wear a mask inside the Marina office.

Onward and upward, let's roll over to a couple items on the marina agenda:

- In order to maintain safety on the docks for you, our boaters, your guests, and our maintenance team alike, dock steps shall not be over eighteen (18") inches wide, and shall be commercially produced and not of the home-made variety. As we walk the docks, any boarding steps that fall outside of this requirement within the slip license agreement, will be tagged and a notice sent to the boater for correction. To be ahead of the game, please take a moment to review your steps and ensure they fit properly. If needed, you may find replacement options through a local boating supply, or other internet retailers. And if you're going to have one shipped to the marina, please give the office a heads up call or email in advance of the package arriving.
- **Do Not** hold open the gate, or piggy back in on other boaters entering or leaving the dock. Security for you and your vessel is very important to us, and it requires your help in not letting someone that doesn't belong on the dock though the gate. If someone slips through, and the person does not belong on the dock, please do not hesitate to call the office during normal hours to report the unknown person, or Brisbane PD's non-emergency line, (415) 467-1212, during after hours.
- Friendly reminder—if you're not an approved live aboard within the marina, you are only allowed to stay aboard your vessel up to 3 days within a 7 day time period.
- Vessel Turn-In Program (a state funded grant)—we still have some time left, and funds available, should it be that time your vessel has passed its prime. Check with our office for potential options to properly dispose of your boat.

Last, but not least, we made it through the switch gear change over near the Office, and we're officially back on PG&E service (docks 1-2, and the yacht club). However,



we will be doing the same project and changing the switch gear for docks 3-6 in the near future. We'll post notices before any planned power interruptions occur.



