PROPOSAL FOR THE PROCUREMENT OF

City of Brisbane Street Sweeping Services

Proposals received until 12:00 P.M., Monday, February 22, 2021.

To the City Council of the City of Brisbane:

The undersigned hereby declares, as bidder, that the only persons or parties interested in this proposal as principals are those named herein, that no Council Member or any other officer or employee of the City in any manner interested directly or indirectly in this proposal or in the profits to be derived from the contract proposed to be taken; that this bid is made without any connection with any other person or persons making a bid for the same purpose; that the bid in all respects fair and without collusion or fraud; that he has read the Notice Inviting Bids and the Instructions to Bidders herein attached and agrees to all the stipulations contained therein; that he has examined the site of the work, the form of Agreement approved by the City, and the specifications and drawings therein referred to, and he proposes and agrees that if his bid as submitted in the attached Bid Schedule be accepted, he will contract in the form so approved to perform all the work mentioned in said approved form of Agreement and the specifications and to complete the same within the time stipulated therein; and that he will accept in full payment therefor the prices named in said Bid Schedule. Said prices are to include and cover the furnishing of all materials, the performing of all the labor requisite or proper, and the providing of all necessary machinery, tools, apparatus, and other means of construction; and the performance and completion of all the work in the manner set forth, described and shown in the specifications or on the drawings for the work in the form of Agreement.

The bidder further agrees that, upon receipt of written notice of the acceptance of this proposal within five (5) days after the date of opening of the bids, he will execute the attached contract in accordance with the proposal as accepted, secure the payment of workers' compensation, furnish the required bonds and insurance, all within five (5) calendar days from date of emailing of said notice of acceptance to him at his email address as given below, or within such additional time as may be allowed by the Owner provided that if said bidder shall execute the contract, secure the payment of workers' compensation, and furnish the required bonds and insurance within the aforesaid time his certified or cashier's check, if furnished, shall be returned to him within three (3) days thereafter, or the bid bond, if furnished, shall become void.

2. The Owner has \$60,000 allocated for contract street sweeping services. The Owner reserves the right and sole discretion to delete bid items and to adjust quantities of the lowest responsive and responsible bidder to arrive at a contract amount that is less than the amount allocated.
3. If any discrepancy between Figures and Words is found, the extended total of “in words” will govern.
4. All prices shall include all taxes, licenses, insurance, transportation, charges and duties, etc. and street sweeping services complete in place.
5. The Owner reserves the sole right to extend this contract twice (i.e., for two additional years), and the Bidder agrees that the adjustment to the contract will be made by multiplying the “Extended Total” costs by a fraction, the numerator of which shall be the Consumer Price Index published by the United States Department of Labor, Bureau of Labor Statistics, for Urban Wage Earners and Clerical Workers, All Items, for the San Francisco-Oakland Statistical Area (“CPI”) published for the month preceding the date of the contract extension, and the denominator of which shall be the CPI published for the month nearest to the date of initial execution of the Agreement for this project, and then totaling the new Extended Total figures to arrive at a new annual contract amount.
