## **SB 1383 REQUIREMENTS**

Beginning January 1, 2022, California Senate Bill (SB) 1383 requires all businesses, multi-family residences (MFD, a residential premise with 5 or more dwelling units), and single-family residences (a residential premise with fewer than 5 units) to arrange for recycling and organic waste collection services. Note that under SB 1383, the term "commercial business" means both businesses and MFDs.

As also required by SB 1383, the City of Brisbane will implement all the requirements of that law by the adoption of Ordinance 663, which created Chapter 8.25 of its municipal code. In general terms, all businesses and single-family residences are required to subscribe to three-container collection service for source separated organic waste (green container), source separated recyclable materials (blue container), and remaining approved waste (grey container).

A brief overview of the available waivers, and the reference to the city's applicable municipal code section is below. Unless a waiver is approved by the city, businesses and properties are required to participate in the mandated collection services.

1. **De Minimis Waiver** (BMC §8.25.080 A), for businesses that generate less than a specified amount of organics

Available for: commercial businesses Collection Service affected: Green

If approved, City may waive the requirement for the business to subscribe to Green container collection.

2. Physical Space Waiver (BMC §8.25.080 B), for businesses with physical space restraints

Available for: commercial businesses Collection Service affected: Blue, Green

If approved, City may waive the requirement for the business to subscribe to Blue and/or Green container collection.

**3.** Collection Frequency Waiver (BMC §8.25.080 C), for businesses and residences with a low waste generation

Available for: commercial businesses, single-family Collection Service affected: Grey, Blue

If approved, City may allow a collection frequency of every fourteen (14) days for Grey and/or Blue containers.

**4. Self-Haul Waiver** (BMC §8.25.090), for businesses and residences that source separate and deliver recyclables/organics to an approved receiving facility

Available for: commercial businesses, single-family Collection Service affected: Green, Blue

If approved, City may waive the requirement to subscribe to Green and/or Blue container collection.
